Requirements of Use:

Step 1: Register this certificate online at www.mystpage.com or mail a completed original Registration Coupon found on the bottom front to: Registration Processing Center, PO Box 24527, Fort Lauderdale, FL 33307-4527. You must register within 60 days of the issue date. If mailed the registration date will be determined by the postmark date on your envelope.

Step 2: You will receive a reservation invoice within 30 days of a valid registration return this along with your \$100 reservation deposit. Your reservation deposit must be in U.S. dollars in the form of a Check, Money Order or Cashiers Check and will be applied towards travel fees and taxes at the time of booking; any remaining balance will be fully refunded by check approximately 10 days prior to your confirmed reservation departure date. You may request the return of your reservation deposit at any time prior to confirmation by contacting Spirit Incentives via telephone, mail, fax or email. Your deposit will not be refunded if you fail to appear on a confirmed reservation.

Step 3: Immediately following receipt and processing of the reservation deposit a registration confirmation letter will be sent directing you to the Choose 2 Cruise travel selection website where you will submit your preferred cruise itinerary and travel (sailing) dates. Arrivals
